- State Testing
 - 21-22 Participation Rate
 - On January 10, 2023, we received notification that we did not meet the mandated 95% participation threshold for state testing for 21-22 and that as a result, we must submit a written plan for improvement to PDE by January 30, 2023. Those plans have to include the following:
 - A narrative that analyzes the root cause or causes for participation falling below the 95% threshold in your LEA.
 - An action plan detailing strategies in which the LEA will engage to increase participation in the 2022-23 school year.
 - A timeline for implementation of each strategy.
 - Monitoring Visit
 - On January 10, 2023, we were monitored at the HS for our Biology Keystone Exams.
 - The monitor from PDE was here for about 1.5 hours, observed administration of assessment, questioned 2 teachers and the School Assessment Coordinator, and asked to see documents related to testing. She also selected 6 PA Secure ID numbers and asked us to show her the

required number of artifacts for college and career readiness required for the state. The District Assessment Coordinator and HS Principal were present as well.

- The outcome of that visit is that we are "meeting expectations". We received a follow up letter documenting compliance and a clean audit.
- 22-23 Winter Keystones
 - Following are the number of students who took each Keystone Exam for a total of 154 exams overall:
 - 53 Literature
 - 97 Algebra I
 - 4 Biology
- 22-23 WIDA/ACCESS for ELLs and Alternate ACCESS for ELLs testing
 - Testing Window is January 5-February 17, 2023
 - As of February 1st, the following assessments have been administered to students for a total of 143 overall
 - 46-Listening
 - 35-Reading
 - 32-Speaking
 - 30-Writing
- 22-23 WIDA/ACCESS for ELLs Field Test
 - Testing Window is February 14-April 17, 2023
 - We must test all of our students who are taking the Alternate ACCESS for ELLs during the WIDA testing window.
